CONDITIONS OF ENTRY

1. Registration and Entries

- All dancers must be paid up registered members of FEDANSA for the current year.
- By entering the competition, the competitors agree to abide by the FEDANSA and ISDF rules and regulations
- All entries must be accompanied by a proof of payment slip. Please write the name of the Athletes on the bank slip.
- Late entries and entries received without proof of deposit will NOT be accepted.
- Entries may only be submitted on the official competition entry form.
- Sections will be combined or cancelled if insufficient entries are received, in accordance with the rules.
- Competitors must note start times, sections will not be re-danced due to late arrivals
- Dancers using unauthorized numbers will be disqualified

2. Syllabus and Dress Code

- NATIONAL SYLLABUS & DRESS CODE WILL BE STRICTLY ENFORCED. All members are urged to seek information from their PAB's if necessary

3. Strictly No Smoking Allowed

- Smoking is strictly forbidden in all areas of the venue!
- The venue operators will impose a R2000 fine on anyone caught smoking in the venue.

4. Cloth number

- Cloth numbers will be allocated at R20, which is refundable on return at the end of the competition

5. General

- By entering the competition, the competitors agree to abide by FEDANSA National rules.
- The organizers are NOT responsible for any injury or loss of property incurred by any competitor or spectator.
- Use of video cameras will be allowed on payment of a fee of R50. Obtain a permit at the door
- The stage area is reserved for officials and guests only
- No food or beverages or any alcoholic beverages are allowed in the venue or at the Competition. Catering facilities will be available
- Application for spectator seats may only be submitted on the officials application form
- Only individual paid for table seats and / specific areas, to occupy seats and / specify areas – this will be checked on a regular basis. So, please hold on to your tickets.
- No cooler bags are allowed into the venue
