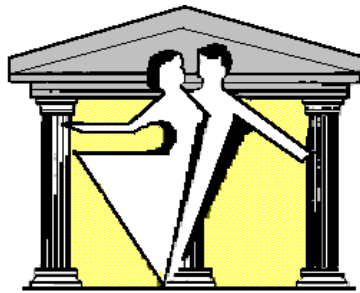

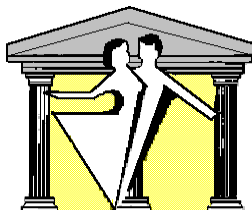

#### CONDITIONS OF ENTRY

- 1 The organizers are not responsible for any loss of property or injury during the running of this competition
- 2 Right of admission is reserved and entry fees are not refundable
- 3 All dancers must be registered members of FEDANSA for the current year
- 4 Strict syllabus and dress code will be adhered to
- 5 Competitors must note start times, sections will not be redanced due to late arrivals
- 6 Competitors must be correctly dressed and ready for prize giving, otherwise they will forfeit their awards
- 7 Sections may be cancelled or combined if insufficient entries are received  
Competitors will be notified and entry fees refunded if sections are cancelled or if entry is refused
- 8 The stage area is reserved for officials and guests only
- 9 By entering this competition competitors are agreeing to abide by the rules of the organisers and FEDANSA
- 10 All entries must include positive proof of deposit of the entry fee, bring your proof to the competition as it **will** be required at registration.  
Ensure that you write your name and dance number and Province on the deposit slip
- 11 All spectators and dancers must adhere to a smart/formal dress code, those wearing jeans, takkies or t/shirts will be denied access to the venue
- 12 Use of video camera R50. Obtain a permit at the door. Persons recording without a permit will be fined R500.00
- 13 Strictly no smoking in all areas of the venue
- 14 No food or drinks to be taken onto the premises, facilities will be available.
- 15 Professionals and Studio/Club Heads must purchase a ticket to gain entry to the competition  
Studio/Club Heads with ten or more couples entered will be entitled to one complimentary unreserved spectator ticket
- 16 Temporary cloth numbers will be available for a refundable deposit of R20.
